Narrative

NARRATIVE:

On 11/01/2018, I was assigned to gate F as a patrol officer working the 49ers VS Raiders football game. I was standing at the exit to gate F with Officer Medina when we heard Frederick Weaver (Witness Frederick) yelling at security to stop Steve Guardado (Suspect) who was running away from Witness Frederick with his brother-in-law (Other Party Victor Soltero. Officer Medina and I detained the Suspect and Witness Frederick told us the Suspect assaulted another fan inside the stadium. I attempted to speak to the Suspect but he would not speak with me.

STATEMENT OF OTHER PARTY SOLTERO:

I spoke with Other Party Soltero and he told me he was not involved in a fight and he did not see the Suspect involved in a fight. I asked him why people were chasing after the Suspect and he said he did not know. I asked him if he heard a fight or argument involving the Suspect and he told me he did not see anything.

It is important to note that video footage shows Other Party Soltero standing near the Suspect during the assault. Other Party Soltero did not appear to be involved in the assault but he was near the Suspect when it took place.

FURTHER DETAILS:

Video was obtained of the incident. In the video, you can see the Suspect striking the Victim multiple times. In the video, you can see the Victim has a bloody face and nose. Detective Torke reviewed the Video footage and he

said he could clearly see the Victim sustained serious bodily injury to his face and nose.

Officer Medina interviewed Witness Frederick and he also interviewed Kelly Weaver (Witness Weaver). Please refer to his supplemental report for further details.

Officer Klein spoke to the Victim and obtained his statement and his information.

EVIDENCE:

I took several photographs of the Suspect and of the Suspect's hands. It is important to note the Suspect sustained a cut on his right knuckle. I also took a photograph of Other Party Soltero. The photographs were uploaded to Evidence.com.

My Body Worn Camera (BWC) was activated during this event. BWC footage was uploaded to Evidence.com.
