## Narrative

OFFICER: S. MEDINA #4042  
SUSPECT: Steve Guardado  
WITNESS 1: Frederick Weaver

Witness 2: Kelly Weaver

### Notification:

On 01/01/18 at approximately 1915 hours, I Officer S. Medina (#4042) was assigned to security detail Gate F at Tasman Dr. / Marie P DeBartolo Way.

### Investigation:

I was standing near the egress area of gate F when I heard a commotion and yelling behind me. I turned around and observed officers taking an H/M/A later identified as (S) Steve Guardado into custody. After (S) Guardado was detained, I met with two witnesses stating that they observed (S) Guardado punching someone inside the stadium and he was trying to get away.

I spoke with the first witness and was told the following statement in summary.

### Statement of (WIT-1) Frederick Weaver:

(W1) Frederick was seated in section 221, row 2, and seat 14 or 15 when he heard people shouting. He stood up to look and approximately 10 rows from the front of a section below him, he observed two males in a fight. He believed the section was possibly 120. The fight lasted for what seemed like 2 minutes. The victim had his legs trapped by the stadium seat and was unable to get free. The victims back was to the field and he was bent over backwards while (S) Guardado punched him repeatedly with a right/left closed fists. The victim appeared to be alone; there was no one else around him. Fans were yelling and trying to wave security down, but there did not appear to be any security in the area.

(W1) Frederick watched the (S) Guardado walk away from the scene with another male. Frederick followed (S) Guardado out of the seating area and into the main concourse where he tried to alert security. (W1) Frederick followed (S) Guardado and never lost sight of him. (S) Guardado walked towards gate F and that was the first time (W1) Frederick saw police and began yelling for them to detain (S) Guardado.

(W) Frederick is willing and able to go to court and testify.

I met with the second witness and was told the following statement in summary:

**Statement of (WIT-2) Kelly Weaver**

(W2) Kelly was seated in section 221, row 2, and seat 14 or 15 when she heard people shouting and pointing to a section below them. She was seated at the time and stood to see what was going on. (W2) Kelly observed (S) Guardado punching a White or Hispanic male on the face. The fight lasted a long time, she would estimate approximately 2 minutes. (W2) Kelly observed (S) Guardado punch the victim over and over again on the face with the closed fist. (W2) Kelly believed (S) Guardado was mostly using his right hand but she couldn't be sure. The victim was bent over backwards with his back to the field. His legs were trapped and he wasn't able to get away from (S) Guardado.

After the fight, (S) Guardado walked away with another male. The victim seemed disoriented and acted like he was going to go after (S) Guardado, but then turned and picked something up off of the seat. The victim was bleeding profusely from his nose and face. (W2) Kelly watched (S) Guardado walk up the aisle, flex his arms at the victim and continue walking away from the scene.

(W2) Kelly and (W1) Frederick were not going to allow (S) Guardado to get away. They followed (S) Guardado and did not lose sight of him while they looked for security. They did not find security until they saw California Highway Patrol at the exit of gate F. They began shouting for officers to detain (S) Guardado for battery.
