RE: Facebook's Civil Rights Audit & Facebook employee Ray Carreira

Hey Sheryl,

On the morning of the $4^{\rm th}$ of July, I read your June 30, 2019 Facebook post, "A Second Update on our Civil Rights Audit."

Sheryl, in the first two lines of your post you state, "Civil rights are the foundation of a free and just society — and something we care deeply about as a company. We want to make sure we're advancing civil rights on our platform..."

And I read the entire Facebook's Civil Rights Audit - Progress Report, dated June 30, 2019.

I also read the attached, Complaint by Mohammad Moneeb, Mohammad Ikram, and Hazakat Ikram which names City of Santa Clara Police Detective Sergeant Ray Carreira, who is now Facebook's (your) Global Security Special Event Manager. See attached, *Moneeb, Ikram and Ikram v City of Santa Clara, Mike Sellers, et al.*, United States District Court (ND CA 2015), Case no. 5:15-cy-01987-NC.

One of the first lines in their Complaint, under 'Jurisdiction' on page 1, says, "This is a civil rights action...arising from unreasonable search and seizure, and use of excessive force."

Sheryl, as you and your team including Laura Murphy, and Megan Cacace probably know, one of the most typical Civil Rights violations involves 'color of law' violations.

"Color of law refers to an appearance of legal power to act that may operate in violation of law. For example, if a police officer acts with the "color of law" authority to arrest someone, the arrest, if it is made without probable cause, may actually be in violation of law."

According to the attached Complaint referenced above, in his capacity as City of Santa Clara Police Detective Sergeant, (I believe he was promoted to Lieutenant before leaving), Ray Carreira filed false police reports and obtained an arrest warrant and search warrant which were unlawful and lacked probable cause.

Sheryl, I have Two Questions and One Statement:

- 1. Do you believe Ray Carreira's actions as outlined in the Complaint, conflict with the current intent of Facebook's Civil Rights initiative?
- 2. Did you and Facebook have a choice of 'two' when you hired Ray Carreira?
- 3. I would appreciate a written response from you.
