

### SUBJECT: Anheuser-Busch 16 oz metal cans being weaponized at NFL Stadiums

Hey Carlos,

It appears there are two separate leadership groups ABInBev and Anheuser-Busch, so I am contacting and notifying you at your New York offices because I am also currently on the East Coast should we need to meet:

### Anheuser-Busch 16 oz metal cans being weaponized at NFL Stadiums

The NFL has known of this dangerous issue for almost a year now. I discussed this during a 'voice to voice' conversation on January 8, 2019 with Billy Langenstein, Director, Investigations & Security Services with the NFL, but after that discussion, Billy and the rest of the NFL 'went dark' on any further communication with me on this and other safety and security concerns at Levi's Stadium.

The Santa Clara Police (California) who provide security for the San Francisco 49ers and the NFL, would not listen to my concerns, and have filed false Police Reports to cover up multiple issues.

Over the last 10 days, I have also reached out to several AB Investor & Media contacts about your 16 oz metal cans which can quickly and easily be 'weaponized'. ABInBev and Anheuser-Busch related employees from several of your entities have looked at my LinkedIn profile, after I have tried to connect or message them, but none of those ABInBev and Anheuser-Busch employees have offered any type of direction to move this safety concern forward. Craig Katerberg, your General Council is one of those individuals. See attached screen-capture from LinkedIn.

Ingvild Van Lysebetten, your Director Global Communications at Anheuser-Busch InBev, has looked at my LinkedIn profile twice and then connected. Unfortunately, however, with Ingvild's role as Director of Global Communications, I would have hoped something as serious as your Anheuser-Busch 16 oz metal cans being weaponized at NFL Stadiums, would have been immediately communicated to you.

Carlos, I am reaching out to you directly to see just what measures if any, you and Anheuser-Busch will be taking to ensure the safety of an average fan attendance of 67,000 at each of the 31 NFL Stadiums, which Anheuser-Busch sells beer at, in these easily modified and weaponized 16 oz metal cans.

Carlos, unless you take immediate action, you and Anheuser-Busch InBev may very well end up like Boeing, who also 'sells' another long cylindrical aluminum vessel. Boeing, similar to Anheuser-Busch InBev, also knew in advance about the dangers of their 737 Max airplanes, yet Boeing chose to let 346 innocent lives be part of their Quality Control experiment: https://www.businessinsider.com/boeing-pilot-737-max-mcas-problems-messages-2019-10




